### Regulation

All pigeons unsold or acquired at auction in previous editions of the Derby Riachos or the Riachos Yearlings Cup will have the right to participate.

Participation in the distance race on behalf of the fancier will imply an activation of the pigeons entered in the race.

After finishing the Riachos Yearlings Cup 2022 and the Derby Riachos 2022 some pigeons can be bought at the auction and participate in the final race.

The pigeons start the championship in the name of Riachos Endurance GP and ring code, and the name will be replaced after the payment of the activation, [or enter directly in the name of the fancier if they have been bought at auction](#)

The pigeons can be activated by former owners until a date to be indicated, after that date anyone can activate the pigeons.

The activation fee for the pigeons is 75 euros per pigeon

To activate the pigeons you have to enter the platform, in your personal area choose the option PIGEONS -> MANAGE PIGEONS and choose the desired pigeons or give the pigeon's number and the name of the pigeon and send to the derby-mail " derbycolumbofiloriachos@gmail.com " the name, number of the activated pigeon and proof of payment.

The registration is only valid after the payment of EUR 75 per pigeon,

After the date given for activation by the owners, the pigeons can be activated by anyone under the same conditions of payment.

To the competitors with pigeons bought at an auction, [a voucher](#) will be credited on their current account with the value of 50% of the entry fee

The long distance ace pigeon is the pigeon with the highest score in the 3 distance races (+500km).

The General Ace Pigeon is the pigeon with the highest score in all the official races.

The pigeons will be entered together with the Riachos Yearlings Cup pigeons (separate list) and in 3 distance races to be designated in due time, the final race being the Valencia del Cid (National race)

The prize table applies for a minimum participation of 220 paid pigeons.

In the event of entries lower than indicated, the prizes will be recalculated in proportion to the number of pigeons entered and paid for. This calculation will be carried out immediately before the 1st distance race.

In addition to the monetary prizes, the following trophies will be awarded:

1st Ace Pigeon **General** Trophy (All races count for M/F and Long Distance)

1st Ace Ace pigeon long distance Trophy (3 long distance races are counted)

Registration will end 8 days before the 1st Long Distance Race

The owner will be entitled to 35% of the sale in all the pigeons that reach a value of 100 euros or more in the auction, the remaining amount will be donated to the Riachos Derby by the participant.

The amounts concerning the % sale of the auctioned pigeons will be paid, by the auctioneers, after all auctions are finished, and the pigeons are paid by the buyers. If a pigeon is sold and is not paid by the buyer, it is auctioned a second time. The percentage for the owner is 35% of the paid sale. If a pigeon is not paid twice, it will not be auctioned again.

In case some pigeon is not auctioned in the first time, the owner loses the right to the percentage of the future sale. (Only the youngbirds with pedigree and title deed will have the right to the %). In case the pigeon fancier does not have Pedigree he will be able to request to the organization of the derby the elaboration of the same (On the value of the % for the participant, incurs the tax at the legal tax in force).

(The owner is considered to be the participant who activates the Pigeon)

Avoid pigeons flying nameless value what is yours!

All the Participating Partners are considered to have been informed of all the points of this regulation when making the payment of the Quota

## TAXES

The amounts mentioned in the Regulations include VAT at the prevailing rate, if applicable. According to the Portuguese law, all participants / members resident in Portugal who receive money from prizes, sales of pigeons or commissions, will be responsible for the payment of IRS tax (25%), regarding those amounts. Derby Riachos will retain this amount, which will be sent to the tax authorities, as required by law. The non residents in Portugal are exempt from the payment of the tax, there will be no retention (25%), the prize will be paid in full, provided that they present a certificate of fiscal residence abroad, or model 21-RFI duly filled and stamped, and if they don't present proof of residence outside Portugal, Derby Riachos will have to deduct 25% of the prize, and then send this money to the Portuguese Tax Authority.

## Missing Cases:

All omissions will be solved by the organization of the Derby Columbófilo de Riachos, according to the regulations. Any eventuality that originates a conflict, not covered by these regulations will be solved by the organization, ruled by the National laws of Portugal, and this decision will be final. The official regulations will be in Portuguese language and will be posted on the event's website, because any translation in another language, may have misunderstandings.
